

# 2024 COLLEGE SCHOLARSHIP PROGRAM

### THE AWARD

Radius Federal Credit Union sponsors a scholarship contest each year, which awards four (4) \$500 scholarships to high school seniors.

## **ELIGIBILITY**

The candidate must be a member in good standing for at least 12 months at our credit union. Scholarship funds may be used for tuition, books, housing, or any other related expenses to a two- or four-year educational institution.

### **APPLICATION PROCESS**

Eligible members must complete this scholarship application. Only one application per student may be submitted along with:

- An official high school transcript
- An SAT/PSAT/ACT transcript (obtained from your guidance office)
- Recommendation and signature of applicant's teacher

The scholarship candidate must sign the certification and release authorization on the back of this booklet. Signature of a parent/quardian is also required.

The entire packet must be returned by the application deadline date. If the application packet is not complete, it will be disqualified.

### **SELECTION PROCESS**

Radius Federal Credit Union will send all applications to a committee. They will review and evaluate each application and select our scholarship recipients. Both subjective and objective criteria will apply. Items such as academic record, essay content and quality, scholastic activities, community service, and personal goals will be considered. Winners will be notified by July 31, 2024.

### **DEADLINE FOR SUBMISSION**

### **ESSAY**

Please use a separate sheet of paper to discuss the following topic. Your response should be between 300-500 words.
